Operator protection

RHINO DSG controls black scurf and some reduction of stem canker on potatoes, when applied to the seed at planting

Crops

Rhino DSG can be used on seed potatoes for the seed, ware or processing market. It can be used on the seed tubers of all varieties of early, second early and maincrop potatoes grown for ware or processing. Check with your processor before using RHINO DSG on the crop.

Timing

RHINO DSG should be applied to the seed tubers at planting.

Disease Control

RHINO DSG is a seed potato treatment which controls black scurf (*Rhizoctonia solani*) and also provides some reduction of stem canker. Where soil borne inoculum is high, treatment of seed tubers with RHINO DSG may not give full protection against infection of stems and daughter tubers.

TAKE OFF IMMEDIATELY all contaminated clothing. DO NOT BREATHE DUST. WHEN USING, DO NOT EAT, DRINK OR SMOKE. WASH HANDS AND EXPOSED SKIN before eating, drinking and smoking and after work.

Environmental protection

DO NOT CONTAMINATE WATER WITH THE PRODUCT OR ITS CONTAINER. Do not clean application equipment near surface water. Avoid contamination via drains from farmyards and roads).

Storage and disposal

KEEP OUT OF REACH OF CHILDREN. KEEP AWAY FROM FOOD, DRINK AND ANIMAL FEEDING STUFFS. BURY OR REMOVE SPILLAGES. KEEP IN ORIGINAL CONTAINER, tightly closed, in a safe place. Empty container completely and dispose of safely. Sacks containing treated seed must not be used for food or feed.

Application

DOSE
Use RHINO DSG at 2 kg per tonne of seed potatoes.

CROP CONDITIONS

For best results the tubers should be clean and free from soil (less than 5% of surface). Disease under areas of soil/dust will not be exposed to dust and will not be controlled. Seed tubers should be of good quality and vigour (free from bacterial rots, physical damage, virus infection etc), and should not be sprouted to such an extent that mechanical damage to the shoots will occur during treatment or planting.

APPLICATION TECHNIQUES

On-planter application - specialised applicators (e.g. Team Sprayers applicator) must be attached to planters to distribute the required amount of product onto tubers as they are being planted.

Storage

Store above 5°C
